### **DISABILITY SAVINGS PLAN**

**Most Significant Initiative for Families in 25 Years.**

The Disability Savings Plan took a huge step towards reality in December. An Expert Panel established by Minister Flaherty recently recommended the creation of a Disability Savings Plan; a Disability Savings Grant and a Canada Disability Bond.

The recommendations, if implemented, will be the most significant federal initiative for families of people with disabilities in 25 years: up to three quarters of a million Canadian families would benefit.

### **The National Ability Center Bobsled Team**

The National Ability Center's bobsled was recently retrofitted by veteran NASCAR driver and founder of the Bo-Dyn Bobsled Project, Geoff Bodine. The sled is equipped with a sleek NASCAR style seat, shoulder harness, seatbelt, roll cage, head rest, and leg straps to accommodate the safety and stability of athletes with disabilities. The sled made its debut at the 2006 World Cup races in Park City, Utah, where athletes Matt Proffitt and Aaron Lanningham became the first athletes with disabilities to forerun a World Cup race.

## **Athlete Bios**

### **Matt Profitt: Breakman-**

Matt Profitt has been bobsledding with the National Ability Center for close to 3 years. He has a below the knee amputation as a result of a rare form of tissue cancer. Profitt is a talented athlete who has run the New York Marathon and rafted the Grand Canyon since his amputation. Profitt pushes the sled solo as the driver, Aaron Lanningham, is already strapped into the sled prior to the run.

### **Aaron Lanningham: Driver-**

Lanningham has been bobsledding with the National Ability Center for over four years. Lanningham has paraplegia as the result of a motorcycle accident. Lanningham is an incredibly skilled bobsled driver who is known for executing very clean runs.
